

Recruitment to the post of Senior Statistical Assistant and Junior Statistical Assistant

No.FST. 1282/93787/CR-266/F-4, dated 18th August, 1988.:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all existing rules, orders or instruments made in this behalf, the Governor of Maharashtra is hereby pleased to make the following rules regulating recruitment to the posts of Senior Statistical Assistant and Junior Statistical Assistant in Class III in the Forest Department under the Revenue and Forests Department of the Government of Maharashtra, namely;--

1. These rules may be called the Senior Statistical Assistant and Junior Statistical Assistant in the Forest Department (Recruitment) Rules, 1988.
 2. In these rules, unless the context requires otherwise ;--
 - (a) "Degree" means a degree of a Statutory University;
 - (b) "Forest Department" means the Forest Department under the Revenue & Forests Department of the Government of Maharashtra;
 - (c) "Government" means the Government of Maharashtra.
 3. Appointment to the posts of Senior Statistical Assistant in the Forests Department shall be made either,
 - (A) by promotion of a suitable person on the basis of seniority subject to fitness from amongst the post of Junior Statistical Assistant in the Forest Department having experience of not less than three years in Class-III service; or
 - (B) by nomination from amongst candidates who,
 - (i) unless already in the service of Government, are not more than 28 years of age;
 - (ii) possess—
 - (a) a Master's degree in Mathematics, Economics, Commerce, Agriculture or Statistics; or
 - (b) A Bachelor's degree in at least second class with Mathematics, Economics, Commerce, Agriculture or Statistics; as subject;

Provided that preference may be given to candidates, who possess experience of statistical work, in Forestry Sector:

Provided further that the age-limit may be relaxed by Government on the recommendation of Selecting Authority, in favour of candidates having exceptional qualifications or experience or both.
 4. The posts filled by nomination shall not exceed 25% of the total member of posts in the cadre from time to time.
 5. Appointment to the posts of Junior Statistical Assistant in the Forests Department shall be made by nomination from amongst candidate who,
 - (i) unless already in the service of Government, are not more than 28 years of age and;
 - (ii) possess a Bachelor's degree in at least second class with Mathematics, Economics, Commerce, Agriculture or Statistics as subject;

Provided that preference may be given to candidates, who have experience of statistical work in Forestry Sector,

Provided further that the age-limit may be relaxed by Government on the recommendation of Selecting Authority, in favour of candidates having exceptional qualifications or experience or both.
6. A person appointed to the posts mentioned in rules 3 and 5 either by promotion or by nomination shall be required to pass the examinations in Hindi and Marathi according to the rules made in that behalf; unless he has already passed or has been exempted from passing these examination.
7. A person appointed to the posts mentioned in rules 3 and 5 shall be liable for transfer anywhere in the State of Maharashtra.
