
Subject :- Scrutiny of applications for grant
of Saw Mill Licences.

A large number of applications are received by Government for grant of saw mill licences. It is observed that these are not properly scrutinised at various levels before submission of the reports to Government despite explicit instructions issued under Government, Revenue and Forests Department Letter, No. SWM. 1081/106836-F-6, dated 20th August 1981 and Circular No. SWM. Letter 1081/106836-F-6, dated 20th October 1981. As a result, considerable time is lost in obtaining the wanted details to enable Government to issue orders in the matter after examining the case in all its aspects. This delay tends to cause no little financial hardship and ~~inconvenience~~ inconvenience to the applicant. Quite often, it is noticed that the Officers do not offer their specific remarks as to whether the application should be accepted or not. Government desire that the Officer concerned should examine each application critically in the light of the above instructions/ guidelines issued, and comment specifically as to whether the xxxxxxx application should be accepted or not, stating precisely the reasons therefor.

2. In order to facilitate speedy disposal of applications for grant of saw mill licences, in future, the accompanying proforma is prescribed wherein the pertinent details may be furnished, along with supplementary information, whenever a

report/remark is called by Government on such applications
It should be noted that the information furnished therein
is duly verified in the field by a responsible Officer and is
complete in all respects.

- (10) Whether municipal and industrial licences have been secured? (If so furnish details with dates).
- (11) Whether ~~any~~ severe inconvenience might be caused to the public if the application is rejected. (If compliance substantiate).


