No. SWM. 1084/CR-32-F-6.—In exercise of the powers conferred by sub-section (1/4) of section 41 of the Indian Forest Act. 1927 (XVI of 1927). in its application to the State of Maharashtra, and of all other powers enabling it in this behalf, the Government of Maharashtra hereby make the following rules further to amend the Bombay Forest Rules, 1942, namely

hese rules may be called the Bombay Forest (Amendment) Rules. 1986.

2. In rule 88 of the Bombay Forest Rules, 1942, after sub-rule (6A), the following sub-rule shall be inserted, namely:—

"(6B) Where it is shown to the satisfaction of the licensing authority that the original licence granted under sub-rule (3) has been lost, torn, defaced or mutilated in any other manner before the expiry of the period of such licence, a duplicate of the said licence shall be granted to the licensee on payment of a fee of rupees fifty."
